Sharie was introduced and Lowell Arwood was present; he asked to address the committee.

Lowell Arwood represents the Clemson Aquatic Team. Lowell thanked the committee for their support in past years. The Clemson Aquatic Team is 100% parent run, 80 plus families with the same amount of swimmers. The organization supports local sponsors before going outside for different things. Currently they have some local restaurants as sponsors; they do resale in order to raise support and it also supports the community. Additionally, the Clemson Aquatic Team supports the torpedoes, which are a local team as well as Olympic swimmers. This is a huge athletic environment across the state. Lowell stated he had been involved many years; he became involved when his son was age 7 and now is 15. Lowell volunteers his spare time from operating the scoreboard and now putting together the ATAX application. Two primary events are held at Fike. During the events they promote Fike as well as sponsors. He reminded us that now there is no swim team at Clemson, issues with pool, without water 1 year, Masters, hold open water events.

Clemson Aquatic Team promotes:

Promote open water event. 1 day - 1 event registration, must be swim member, 5k 3k 1k ½k 10/k, register attend event, must be affiliated.

Standard pool gets funds. Not using. Produce the amount and ask for money next.

Tried to give unique perspective on events and how they are arranged to allow teams to experience Clemson. Fike events have two different groups, Friday, Saturday, Sunday/ Saturday split/. Lowell was thanked for his comments.

The state regulations rules and codes were read to the committee and rules for approval were passed out.

Committee reviewed the applications one at a time.

**Pendleton Historic District:** Recommended \$2,000

They did not apply last year. This year the rooms that they stated they would fill seemed speculative in the amount they would generate to the Clemson area.

**Oconee Conservatory of Fine Arts:** Recommended \$1,000

Upstate Quilt Trail: There is a quilt in Clemson and the trail is gaining more popularity. The Arts Center will monitor this year to determine tourism and hospitality impact.

**Old Stone Church Society:** Recommended No Funding

No funding due to it not being a central visitor center designated by the City of Clemson and their application did not meet standards for ATAX.

**Clemson African American Museum:** Recommended \$500

**Clemson Aquatic Team:** Recommended \$6,000

The events do generate hotel stays as well as tourism.

**Clemson Literary Festival:** Recommended No Funding

While in the past there were funds granted; however, the reach and draw of tourists does not meet the standard definition or at a level the committee sees as beneficial for tourism impact. Additionally, they stated in their application a reason for requesting funding was the University is dropping funding for their organization.

**Greater Clemson Music Festival:** Recommended \$2,000

There is some tourist impact. There are some concerns as to Councils original intent and the amount of outreach to other areas. The name changes and the establishment of a self-sustaining event was the original intent.

**City of Clemson Parks and Recreation:** Recommended \$20,000

The event was an overwhelming success.

**Pendleton Historic Foundation:** Recommended \$2,000

**Clemson Area FCA:** Recommended \$1,000

**The Arts Center:** Recommended \$12,000

Tommye Hurst abstained

**The Arts Center Application 2 was rescinded due to event being held prior to funding being allocated**

**T. Ed Garrison Arena:** Recommended \$6,000

They have re-established Clemson Hotels as host hotels.

**Brooks Center for Performing Arts:** Recommended \$6,700

The application indicated that advertisement was using local promotion which does not meet requirements of 50 miles out.

**Clemson Area Chamber of Commerce:** Recommended \$115,800

The Chamber's application as well as designation of city tourism has shown a dramatic impact. The Sports Council as well as the Chamber is bringing fresh new ideas and their cooperation is impacting city tourism.

**Total: \$175,000**

**The committee feels these recommendations of allocations are the best utilization of ATAX dollars and represent the greatest impact and return.**
