

AN ORDINANCE TO AMEND SECTION. 19-802. OFF-STREET PARKING SPACE REQUIREMENTS IN THE CITY OF CLEMSON ZONING ORDINANCE TO REVISE THE PARKING REQUIREMENTS FOR ELEMENTARY SCHOOLS AS FOUND IN TABLE 19-802 AND TO AMEND SECTION 19-807. VEHICULAR USE AREA DESIGN STANDARDS FOR USES OTHER THAN SINGLE-FAMILY OR DUPLEX USES BY AMENDING TABLE 19-807 F. TO ALLOW USE OF OCCATIONAL PARKING TO FULFILL VISITOR PARKING REQUIREMENTS FOR SAME AS FOLLOWS:

Educational Services	Kindergarten and Elementary Schools	1 per each classroom and 1 per each employee, plus 1 space for each 40 students of design capacity for visitor parking provided, however, that no more than 50% of the visitor parking may be provided as occasional parking.
	Kindergarten, Elementary, and Secondary Schools	1 per class room, 2 per office, plus 1 per 4 seats in assembly area based upon maximum occupancy
	Colleges, Universities, other Professional, Technical and Trade Schools, and Educational Support Services	1 per 200 square feet of gross floor area

Section 19-807. Vehicular Use Area Design Standards for Uses Other Than Single-Family or Duplex Uses.

F. Paving

1. Vehicular use areas surfaced with asphalt, concrete, bituminous, or other alternative paving material, including grass pavers, porous concrete, and other similar materials, subject to approval by City Engineer; however gravel or similar material are not allowed except for areas used for ~~overflow, special events, and peak parking~~ **occasional parking as permitted in Table 19-802**. Off-street parking facilities shall be surfaced with concrete, asphalt, brick or paving stones.
2. Off-street parking areas shall be maintained in a clean, orderly, dust-free, and weed-free condition at the expense of the owner or lessee and not used for the sale, repair, or dismantling or servicing of any vehicles, equipment, materials, or supplies.
3. All access ways and aisles shall be clearly identified.
4. Any barriers associated with occasional parking shall be no closer than six feet from any tree.
